Information We Collect

Use of Information

2.1 Provision of Services

We use the information collected to provide and improve our e-Learning Platform, personalize user experience, communicate with users, respond to inquiries, process payments, and offer relevant educational content.

2.2 Statistical Analysis

We may use aggregated and anonymized data for statistical and analytical purposes to understand user behavior, improve our platform, and enhance our services.

2.3 Marketing Communication

With the user's consent, we may use their contact information to send promotional materials, newsletters, updates, and relevant information about Outgrow Your Garage. Users can opt-out of marketing communications at any time.

Information Sharing

If we become aware that we have inadvertently collected personal information from a child under 13, we will take reasonable steps to promptly delete the information.
